#### FREELANDS PAINTING FELLOWSHIP 2021

at the University of Brighton, Manchester School of Art, Manchester Metropolitan University and Bath School of Art, Bath Spa University ("the Universities").

The University of Brighton is pleased to announce its participation in the first Freelands Painting Fellowship.

Alumni of BA Fine Art from the University of Brighton who graduated at least 3 years ago (July 2017 or earlier) and have maintained a painting practice since, are invited to apply to become the Freelands Painting Fellow at the University of Brighton or Bath Spa University or Manchester School of Art, Manchester Metropolitan University of Art.

The fellow will receive a studio at the host university, mentoring sessions with a member of the teaching staff and a grant of £20,000 for the year.

## Programme Overview (the 'Project')

The Project is a partnership between Freelands Foundation and the Universities, with Freelands Foundation providing the funding and infrastructure and the Universities overseeing the individual fellowships, recruiting and support of the artists.

Alongside the establishing of the fellowships themselves, Freelands Foundation will initiate a debate around the teaching of painting, setting up regular forums for course leaders and lecturers to meet and share ideas and practice.

Each fellowship year will conclude with a group exhibition, held at the Freelands Gallery, showcasing the works of that year's fellows. This exhibition will be accompanied by a fully illustrated catalogue and include critical writing on each of the artists, providing them with further important evidence at a significant point in their early careers.

The fellowships will run for 12 months, from January to December, as a calendar rather than academic year\*. The pilot will commence in January 2021.

The Universities will provide the following:

- designated studio space for the fellow with sufficient access\*
- a teaching mentor
- regular opportunities to assist in the delivery of tutorials, and participate in crits
- at least one opportunity to deliver an artist talk
- an exhibition opportunity towards the end of the fellowship (either onsite at the university or a connected gallery)
- support in finding suitable accommodation in the area.

The Universities will also be responsible for administering the Grant to the fellows.

Freelands Foundation will provide the following:

- funding of the fellowship ('Grant')
- opportunities for each fellow to visit each of the other participating Universities to spend a day
  as a visiting lecturer, and to deliver an artist talk, as well as organising regular meetings (two
  annually) with course leaders and lecturers to share practice and approaches\*
- a group exhibition, at the Freelands Foundation gallery, at the close of the fellowship
- an accompanying publication, to be published to coincide with the London exhibition.

Please ensure that you meet the required eligibility and read the **terms and conditions before applying**.

#### Eligibility

You must indicate how you meet the following criteria:

- a) you must have completed a BA Fine Art Painting from University of Brighton at least three years ago (July 2017 or earlier)
- b) you must demonstrate a commitment to your artistic practice and a strong portfolio of work.

### **How to Apply**

Applications must include:

- five images of recent work (made within the last two years)
- a 250 word artist statement
- your CV listing all relevant experience.

Please indicate your preferred university for consideration for the Fellowship – Bath Spa or Manchester Metropolitan University of Art, at the top of your personal statement.

The above should be put together in one PDF document with images no larger than 72 DPI.

A shortlist of candidates will be selected by a panel of staff from the University of Brighton, School of Art and shall be invited to attend an interview at the host university.
